

Official Rules for the 12 Days of Checkpoint Sweepstakes

No Purchase or Booking Necessary. A Purchase or Booking Will Not Increase Your Chances of Winning.

- Eligibility:** The Sweepstakes is open only to legal residents of the United States who are at least eighteen (18) years old. Employees of Beasley Media Group, LLC d/b/a Checkpoint XP (“Sponsor”), as well as the immediate family (spouse, parents, siblings, and children) and household members of those employees, are not eligible to enter.
- Entry Period:** The Sweepstakes begins on December 10, 2018 and ends on December 21, 2018 (the “Entry Period”). There will be one (1) drawing associated with each day in the Entry Period. Sponsor’s computer is the official time-keeping device for the Sweepstakes.
- How to Enter:** To enter, log into your Twitch account between 5:30 PM ET and 6:30 PM ET any day during the Entry Period and submit a comment in the Checkpoint XP Twitch channel chat. (If you do not have a Twitch account, you can create one for free.) There is a limit of one (1) entry per person per day during the Entry Period. Sponsor reserves the right to reject any entries that are created by automated means, as well as any entries that are obscene, indecent, or otherwise inappropriate. By entering the Sweepstakes, you indicate your full and unconditional agreement to, and acceptance of, (a) these Official Rules and (b) Sponsor’s decisions regarding the Sweepstakes, which are final and binding. Winning a prize is contingent upon fulfilling all requirements in these Official Rules.
- Drawings:** Each day of the Entry Period, Sponsor will select one (1) potential winner in a random drawing of all entries received during that day. The odds of being selected depend on the number of entries received during the given day. The winner will be announced on the show and contacted through Whisper on Twitch. Non-winning entries will not rollover into subsequent random drawings in the Sweepstakes, if any. Entries will only be valid for the random drawing corresponding to the day the entries were submitted.
- Potential Winner Requirements:** Except where prohibited, a potential winner may be required to complete and return a declaration of eligibility and liability/publicity release within ten (10) days of notification. If a potential winner fails to sign and return these documents within the required time period, Sponsor may select an alternate potential winner in random drawing of the remaining entries. No more than three (3) alternates will be contacted.

For all Prizes: A winner is responsible for paying any applicable income taxes and any and all other costs and expenses not listed above. Sponsor’s failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. Proof of sending any communication to Sponsor by mail shall not be deemed proof of receipt of that communication. The Sweepstakes is subject to federal, state, and local laws and regulations and is void where prohibited.
8. **Release and Limitations of Liability:** By entering, you agree to release the Sponsor, its parents, subsidiaries, affiliates, and each of their respective officers, directors, employees, and agents (collectively, the “Released Parties”) from any claim or cause of action arising out of participation in the Sweepstakes or receipt or use of any prize, including, but not limited to: (a) unauthorized human intervention in the Sweepstakes; (b) technical errors that may affect the Sweepstakes; (c) printing errors; (d) lost, late, postage-due, misdirected, or undeliverable mail; (e) errors in the administration of the Sweepstakes; or (f) injury or damage to persons or property. You further agree that in any cause of action, in no event shall the Released Parties be liable for attorneys’ fees or other legal costs. You waive the right to claim any damages whatsoever, including, but not limited to, punitive, consequential, direct, or indirect damages.

biographical information, and state of residence for promotional purposes in any media without further payment or consideration.

10. **Disputes:** You agree that any disputes, claims, or causes of action arising out of, or connected with, the Sweepstakes shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in Naples, Florida. All issues and questions concerning the construction, validity, interpretation, and enforceability of these Official Rules, your rights and obligations, or the rights and obligations of Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of Florida, without giving effect to any choice of law or conflict of law rules (whether of Florida or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than Florida.
